DIRECTIONS FOR USE

Highly flammable liquid and vapour. Read and understand the Safety Data Sheet before using this product.

APPLICATION

- Cleaning

When used for surface preparation the "wipe on/wipe off" technique must be used, changing cloths regularly. Do not scrub the surface. Always ensure surface is dry before proceeding with adhesive application.

Do not allow solvent to flash off the surface.

- Thinning

Do not exceed the amount thinner recommended on the product Technical Data Sheet. If no maximum thinner addition is given work on a maximum thinner addition of 10%.

Stir mixture well to ensure even consistency.

- Reactivation

Apply a thin film Solvent No. 2 to neoprene contact adhesives to reactivate the adhesive on each side. Bond as per normal for contact adhesives.

LIMITATIONS

- Always test compatibility in an unobtrusive place before using for cleaning.
- Not suitable for delicate substrates.
- Do not use for purposes other than those intended.
- Do not use to clean hands.

STORAGE AND SHELF LIFE

Store in cool, dry conditions out of direct sunlight below 25°C and away from naked flame or sources of heat. Store according to Dangerous Goods regulations. Shelf life is 24 months from date of manufacture if stored in cool, dry conditions in original, unopened containers.

DISPOSAL

Empty containers, once dry, may be disposed of via local landfill.

If spilt, beware of flammable vapours. Absorb product with clay, sand or earth. Collect in properly labelled metal containers. Dispose of according to local authority regulations. Do not dispose of down drains or into waterways.
