4.1. Description of first aid measures

General information

Remove affected person from the danger area and lay down.

After inhalation

Provide fresh air. If breathing is irregular or stopped, administer artificial respiration. No mouth-to-mouth or mouth-to-nose resuscitation. Use Ambu bag or ventilator. Medical treatment necessary.

After contact with skin

After contact with skin, wash immediately with plenty of water and soap. Take off contaminated clothing and wash it before reuse. Grease skin after contact In case of skin irritation, consult a physician.

After contact with eyes

After contact with the eyes, rinse with water with the eyelids open for a sufficient length of time, then consult an ophthalmologist immediately.

After ingestion

4.2. Most important symptoms and effects, both acute and delayed

7.1. Precautions for safe handling
